2. Informed board of cost to repair Case 580K Backhoe: Cost exceeded entire budgeted amount for category (5120) Maintenance-Equipment. It was suggested to separate the category into 2: Equipment Repairs and Equipment Maintenance plus an increase to \$25,000 for Maintenance Equipment.

of the 3 trees along north driveway at a cost of \$6,700.
