READING OF MINUTES: Minutes of the meeting from September 24, 2024, were reviewed by all present. After a few minor changes, a motion was made to approve the minutes by Chairperson Tamara Jackson and seconded by Secretary Wesley Carlson. All in favor, motion carried.

SUPERINTENDENT'S REPORT: 1.) Informed Board of board member's term that is set to expire on January 6, 2025.
